<p>Sub-entity Background:</p> <p>The Committee on Professional Responsibility and Conduct (“COPRAC” or “the Committee”) is composed of 16 persons appointed by the Board of Governors. Its membership consists of a chair, vice-chair, special advisor and 13 members, including, at least one public member, with expertise or an interest in attorney professional responsibility. The charge of the Committee is as follows (e.g.):</p> <p>The Committee shall assist members of the State Bar in their desire to appreciate and adhere to ethical and professional standards of conduct, which assistance shall include, but is not limited to:</p> <ul style="list-style-type: none">a. Issuing to members of the bar advisory opinions on the ethical propriety of hypothetical attorney conduct at the request of members of the State Bar or on its own initiative;b. Responding to such inquiries from members of the bar; andc. Publishing its opinions. <p>The Committee shall assist the Board of Governors by studying and recommending additions, amendments to, or repeal of Rules of Professional Conduct of the State Bar or other laws governing the conduct of attorneys, and perform such other functions as may be assigned to the Committee by the board.</p> <p>The Committee shall encourage the establishment of and provide assistance to local bar association ethics committees.</p> <p>The committee shall assist the public, including lawyers and judges, to understand the professional obligations of members of the State bar, which assistance shall include, but is not limited to, sponsoring educational programs and conferences.</p> <p>(Source: Board of Governors’ Resolution, July 1979. [The Standing Committee on Professional Responsibility and Conduct is the successor to the Committee on Professional Ethics established by resolution of the Board of Governors of the State Bar of California adopted September 29, 1964.] Board Book Tab 19, Standing & Special Committees, Section 16, Committee on Professional Responsibility and Conduct.)</p>

Proposed Activities	
<u>Activity 1(a)</u>	<u>Status/Time Frame:</u>
<p>Meetings</p> <p>To carry out its charge, 9-10 day-long meetings will be held in FY 2008. Most of these meetings will be held in-person at the State Bar facilities in San Francisco or Los Angeles, or at an airport hotel location. Meetings scheduled later in the fiscal year will be planned as video-conference meetings. However, the Committee hopes to realize budget savings and use these savings to convert these video-conference meetings into in-person meetings. Given the nature of the Committee's work, in-person member participation is the most productive meeting format.</p>	<p>The schedule of meetings has not yet been set. Ordinarily, the meetings are scheduled about 6 – 8 weeks apart with the location alternating between northern and southern California sites.</p>

Proposed Activity Budget for Activity 1(a)
The proposed budget to carry out COPRAC's overall operation is found on page 16. Of the entire \$37,700 requested, approximately \$32,000 is attributable to the cost to carry out proposed Activity 1(a). This figure includes the estimated volunteer and staff travel expenses, catering, photocopying and mailing expenses associated with circulation of the assignment and agenda mailings for each meeting.

<p>Consideration of draft COPRAC comments on Rules Revision Commission rule proposals are primarily accounted for under the meeting expenses incurred and reflected under Activity 1. Attendance at the Rules Revision Commission meetings is generally covered by a member of the subcommittee local to the meeting site to eliminate or minimize additional travel expenses. On rare occasions, travel expenditures are realized from COPRAC members attending a Rules Revision Commission meeting at a site requiring air travel or other additional travel expenditures.</p>

Proposed Activity Budget for Activity 3(a)
<p>The proposed budget to carry out COPRAC's overall operation is found on page 16. Of the entire \$37,700 requested, approximately \$10,500 is attributable to the cost to carry out proposed Activity 3(a), which is significantly offset by anticipated revenue from registration fees of \$7,200, for a total expenditure of \$3,300. The expenses include estimated volunteer, outside speakers' and staff travel expenses, catering, publicity, invitation and registration packet mailings, and production of program course book.</p> <p>Staff and the Committee are continuing to explore ways to reduce expenditures. The last several Symposiums have been co-sponsored by law schools and other educational organizations with the meeting space being provided at nominal cost, or free of charge, and the 2008 budget includes this assumption.</p>

How Activities Address State Bar Strategic Plan

The Committee on Professional Responsibility and Conduct particularly furthers the following goals and strategies:

Goal 1: The public is protected and served by attorneys and other legal service providers that meet the highest standards of competency and ethics.

Strategy 1.4 Competence and Ethical Standards. Ensure the high levels of competency and ethics of all attorneys and others regulated by the State Bar.

Goal 2: The State Bar provides a wide array of services and benefits to members that meet their professional development, business, and personal needs.

Strategy 2.2 Professional Development Services. Seek ways to improve and inform members about professional development opportunities and services, including continuing legal education (MCLE), the Ethics Hotline, Alternative Dispute Resolution, Fee Arbitration and Lawyer Assistance programs.

Strategy 2.3 Communications with Members. Use technology to improve the quality of quantity of methods for receiving information from and providing information to members and member groups.

Re: Goals 1 & 2, publication of proposed and final versions of formal ethics opinions (posted on the State Bar website), assisting the Board in considering rule amendment proposals, holding the Annual Ethics Symposium and other CLE activities (such as the Annual Meeting programs and local/specialty bar outreach programs) protects the public by assisting attorneys in maintaining high ethical standards.

Goal 3: All people have access to high quality legal services regardless of financial or other circumstances.

Strategy 3.4 Alternative Dispute Resolution. Support the appropriate use of alternative dispute resolution processes, particularly mediation, and actively participate in the providing of those alternatives to all court users including self-represented litigants.

Strategy 3.5 Limited Scope Representation Legal Services. Identify ways in which attorneys can appropriately provide “unbundled” legal services to provide limited and specific services to litigants without undertaking full case representation.

Re: Goal 3, comments made to the Judicial Council on its proposed rules and guidelines, including ethical guidelines for contract arbitrators, ethical guidelines for mediators, and rules concerning the provision of limited scope of representation to litigants help ensure not only that these important initiatives are achieved, but that the services are delivered with the highest ethical standards.
