

Candidate Statement of Pearl Gondrella Mann
for Vice President

Dear Fellow Trustees:

It has been an honor to serve on the State Bar Board of Trustees (BOT) since my election in 2011. Our Board has been amazingly productive, accomplishing much in a respectful and collegial manner, but we must remain vigilant and consistent in our oversight and action as we continue enhancing the State Bar's protection of the public.

I seek your support of my candidacy for Vice President because I believe that I can make a significant contribution and help to improve the legal profession that has been so wonderful to me. I have the energy, passion and time to serve as Vice President if you entrust me with that position. My qualifications include extensive leadership experience, my dedication to public service, a collaborative leadership style, involvement in strategic planning for a wide variety of organizations and the ability to reduce my case load to contribute the necessary time to do the job well.

I have served as president and vice president of the statewide California Women Lawyers and of numerous legal and community association boards, such as the Orange County Barristers, Orange County Women Lawyers, Lex Romana - Italian American Lawyers, my law school alumni association, Fullerton Public Library Board of Trustees and League of Women Voters of North Orange County, as well as a vice president of the Council on Aging - Orange County. In the Orange County Bar Association (OCBA), I have been a member of the Board of Directors for ten years and chaired Bridging the Gap, the Pro Bono and Law Day Committees and the Appellate Law, Trusts and Estates and Elder Law Sections. Prior to my election to the BOT, I was a member of the State Bar's Administration of Justice Committee and the last Chair of the Committee on Women in the Law, one of the diversity "access committees". (A copy of my resume is attached.) All of these groups engaged in some level of strategic planning, sometimes led by expensive facilitators, but it was disappointing when the plan was not implemented beyond one year in most of those groups.

Last year, serving under the chairmanship of Luis Rodriguez on the Task Force on Discipline System Metrics and Monitoring was challenging but rewarding. The frequent reports with colorful charts and graphs illustrating the Bar's progress in managing complaints and reducing the discipline backlog which we currently receive are the result of the Task Force's work as implemented by our clever staff and are useful in our oversight of the discipline function. Serving this year as Chair of the RAD/MOC Working Group on Senior Lawyers and the Task Force on Sections and as Vice Chair of MOC, as well as my experience as a member of Regulation, Admissions and Discipline Oversight Committee (RAD) and Nominations and Appointments (NAC) has given me greater insights into the significant issues we must continue to address.

I have been a speaker about the State Bar at four swearing-in ceremonies, at a number of law school graduations and honors programs and to other groups to explain what the State Bar does and why it is not like other “bar associations”. I also participated in two Discipline Days and several public hearings and meetings which familiarized me with the State Bar’s procedures and the public’s perception of them.

If elected Vice President, I will enjoy working with staff to organize a productive, inspiring planning meeting to allow us to update and modify our Five-Year Strategic Plan and continue the momentum. I will enthusiastically support the new President’s priorities, cheerfully undertake any other tasks he assigns me and respectfully step in to help should he be unable to perform any of his duties.

I believe all of the Trustees agree that our top priorities will continue to be to improving and strengthening our licensing, regulatory and disciplinary functions in order to protect the public and supporting efforts to restore court funding to improve the public’s access to justice.

There are other issues which deserve our focus as well. Implementing the recommendations of the Task Force on Admissions Regulation Reform and the Limited Licensing Working Group; increasing the delivery of legal services to the poor; inspiring California’s lawyers to improve professional competence, plan for the future and commit to public service; promoting diversity and gender equity in the profession; facilitating the processing of awards from the Client Security Fund; and assisting the many young and aging lawyers who open solo offices when they cannot find jobs should all be given priority. Whether or not I am elected, I look forward to working on these issues with the BOT.

After 27 years in practice, I still believe that law is a noble profession. For all those years, I have been committed to “making a difference_ by providing greater accessibility to justice for the public, especially the poor, the elderly and the disabled, and by advocating for diversity and gender equity in the legal profession. In my solo practice, located in Fullerton, I emphasize elder law, conservatorships and estate planning, and approximately 30% of my cases are *pro bono*. I also sit as a Superior Court settlement conference judge and volunteer at the Probate Court Conservatorship Clinic and the Public Law Center (PLC), assisting people who cannot afford a lawyer. In 2010, the PLC named me as its Attorney of the Year, and I received the State Bar Wiley W. Manuel Award for Pro Bono Services to the Poor in 2011. I was deeply honored by the recognition, but the satisfaction of helping people who could not help themselves or afford to pay someone to help them was the greater reward.

Thank you for your consideration. If elected, I would be pleased and honored to serve as Vice President of the State Bar Board of Trustees.
