SUBJECT: California Paraprofessional Program Working Group – Appointment of Members

EXECUTIVE SUMMARY

At its March 12, 2020, meeting the Board of Trustees approved the California Paraprofessional Program Working Group (CPPWG) charter, appointed members to the CPPWG, and provided authority to the CPPWG Chair to fill vacant appointment slots based on anticipated appointments from identified stakeholders. Since that meeting, some vacancies have been filled; this agenda item requests that the Board provide the CPPWG Chair with the authority to fill the two remaining vacant slots based on nominations from stakeholders other than those specified in the March 12, 2020, agenda item.

BACKGROUND

At its January 24, 2020, meeting, the Board of Trustees established the California Paraprofessional Program Working Group (CPPWG), and directed staff to develop a charter, identify the appropriate size and composition of the working group, and solicit interest in participation in the working group. At its March 12, 2020, meeting the Board approved a charter, appointed members, and authorized the Board-appointed Chair, Chris Iglesias, to fill the remaining vacant slots. While most of the stakeholders identified in the March agenda item nominated members to the CPPWG, there are two remaining vacancies. The current working group composition is lacking in racial/ethnic diversity and direct consumer voice. This item seeks Board approval for flexibility in filling the remaining vacancies, with a particular goal of addressing identified gaps in current CPPWG membership.

DISCUSSION

The CPPWG's two remaining vacancies were intended to be filled by nominees identified by the Department of Consumer Affairs (DCA) and the Senate Judiciary Committee.

The Senate Judiciary Committee has not nominated a representative to the CPPWG. While staff has been in communication with the DCA, which hopes to identify a nominee for the CPPWG, it is not certain that such a nomination will be made. The CPPWG would benefit from a full complement of members; this agenda item seeks flexibility in filling the remaining vacancies on the CPPWG, specifically by eliminating the requirement that the remaining vacancies be filled by nominees of the Senate Judiciary Committee and DCA. If afforded this flexibility, the chair will make efforts to use the remaining appointments to increase the diversity of the CPPWG.
