It was moved, seconded and duly carried that the fee to apply for the Provisional Licensure Program is \$75, with a fee \$50 for fees paid by IOLTA funded organizations for Provisionally Licensed Lawyers employed by them, and no fee for applicants who are seeking to participate in the program in a non-paid position.

It was moved, seconded and duly carried to eliminate the requirement that applicants must take and pass the Multistate Professional Responsibility Examination (MPRE) to be eligible for the program, and instead to require that, if the applicant had not sat for or passed the MPRE prior to submission of an Application for Provisional Licensure, the applicant must complete the legal ethics components of the New Attorney Training within the first 30 days of licensure as a Provisionally Licensed Attorney, or within 30 days from when the training components are made available.

Should an applicant take but not pass the MPRE, their PLL status will not be affected.

(A) It was moved, seconded and duly carried that the rule be further clarified that Provisionally Licensed Lawyers need not have passed *or sat for* the Bar Exam, and clarified the eligibility for supervising lawyers extends to those who have practiced law for at least four years in any United States jurisdiction and have actively practiced law in California *or taught law at a California Law School* for at least two years immediately preceding the time of supervision.
