### **Refusal-of-Admission and Suspension for Tax Delinquency (AB 1424, Stats. 2011, Ch. 455)**

This item is currently on both the RAD and MOC inventories but because the issue relates strictly to the regulation of attorneys and bar applicants, it is appropriate that it go before RAD for action and MOC for information. AB 1424 is directed at the 500 largest state tax delinquencies over \$100,000. The bill provides for suspension of the professional license or denial of license to an applicant who is a delinquent taxpayer (Franchise Tax Board or the State Board of Equalization). The Bar is covered by AB 1424 and the item proposes two new California Rules of Court and a new State Bar rule.

### **Suspension for Failure to Comply With Child or Family Support Order**

California Rule of Court 9.22 and State Bar rule 2.34 govern suspension of a member who fails to comply with court-ordered child or family support. **Update to Discipline Cost Formula**

In January 2011, the then-Board of Governors adopted a cost model for attorney disciplinary matters in response to a recommendation from the California Bureau of State Audits. The resolution applied “in all matters in which a notice of disciplinary charges or a pre-notice stipulation pursuant to Rules 132 – 135...is filed...” It has come to staff’s attention that this language needs to be modified so that it can be applied to conviction referral matters, which are generally initiated by a conviction transmittal. This modification is not substantive and is intended to conform the rules to practice.

**Elimination of Bias Video Project**

The purpose of this project is to produce and disseminate a 30-minute, professional quality video depicting the experiences faced by attorneys from diverse backgrounds in the practice of law. The video will provide real-life examples of the subtle biases they face in the work setting, court, and other areas of practice. Similar videos were produced about 10 years ago and are now outdated in terms of the nature and scope of the biases depicted and the increased complexities/subtleties of the social interaction and experiences on the part of legal employers, clients and attorneys involved. A training manual would also be produced to assist the "trainers" showing the video. The video would provide the basis for ongoing dialogue and discussion among members of the profession about the various scenarios and how to address them in the practice setting. The showing of the video combined with discussion would take one hour and fulfill the 1 unit EOB MCLE credit.
