**SUBJECT:** Members' Requests for Adjustments to Fees and Penalties

---

## EXECUTIVE SUMMARY

Members may request that adjustments be made to their membership fees and penalties. Title Two, Rule 2.16 (H) of the Rules of the State Bar states that the Board reserves the right for good cause grant requests for waivers that were denied by staff and to consider all other requests for waivers. This item consolidates several member requests for which the Board's Membership Liaisons have determined that good cause exists to recommend fee adjustments.

## BACKGROUND

Rule 2.16 of Title Two of the Rules of the State Bar of California provides for waiver of annual membership fees and penalties. Rule 2.16 (C) specifies three circumstances where staff may grant a member's request for waiver of up to \$1,000 in annual membership fees and penalties for the year in which they are due. These circumstances are that 1) the member serves full-time as a magistrate, commissioner, or referee for a state or federal court of record, 2) the member is a retired judge who accepts assignments from the Chief Justice in the assigned judges' program of the Administrative Office of the Courts, or 3) the member's total gross annual household income from all sources is \$20,000 or less, in which case the waiver is 50% of the annual membership fees.

Rule 2.16 (H) provides that the Board of Trustees reserves the right for good cause 1) to grant requests for waivers denied by staff and 2) to consider requests that fall outside

of staff's authorization for granting a waiver of fees and penalties. Traditionally, Board members who are appointed as Membership Liaisons have reviewed the waiver requests that come under Rule 2.16 (H) and have made recommendations to MOC and the Board of Trustees where the Liaisons determined that good cause exists to make fee adjustments.

In assessing what constitutes good cause for purposes of determining whether or not the Board of Trustees should grant a fee waiver, the member's justifications for a fee waiver should be weighed against the public policy reasons for imposing annual membership fees. The primary public policy reason for imposing State Bar membership fees is to provide funding for an effective attorney regulatory system that protects the public and eases the burdens on the courts. The system is funded solely through the imposition and collection of annual fees. For this reason, membership fee waivers should not be granted as a matter of course, but rather should be limited to extraordinary compelling, exigent situations where the member did not contribute to the cause of the failure to pay full fees.

## ISSUE

Do the Board Committee on Member Oversight (MOC) and the Board of Trustees agree with the recommendations of the Membership Liaisons that good cause exists to grant the requests for fee adjustments for the State Bar member(s) listed below? MOC and the Board of Trustees may deny or agree in whole or in part with any of the recommendations.

## DISCUSSION

The following member(s) have requested adjustments to their annual State Bar membership fees. Staff has reviewed these requests and established that they do not meet the qualifications for staff waivers (See Rule 2.16 (C)), or that the amounts are greater than \$1,000. The requests that are less than \$1,000 have been reviewed and denied by staff, and the member(s) have appealed to the Member Liaisons. The Liaisons have determined that good cause exists to recommend the adjustments.

**Julie Aston (#41989)** Admitted June 19, 1968. Current status is Active. Member's fees are paid in full. Member requests a waiver of \$200. Member was randomly selected for an audit of her 2012 scaled fees, the billing department determined that she did not meet the income requirements and required her to repay the \$100 reduction and assessed her a \$100 penalty. Member's request is based on financial hardship. Member has not received a waiver in the past. Member has submitted a statement and supporting documentation.

**Renee Baum (#26675)** Admitted January 10, 1956. Current status is Active. Member's current balance is \$202.50. Member requests the scaled rate for 2013 and a waiver of the \$100 late payment penalty. Member's request is based on her claim that she mailed her payment by the February 1 deadline. Member has not received a waiver in the past 5 years. Member has submitted a statement.

**Mark S. Collins (#60849)** Admitted December 18, 1974. Current status is Active. Member's current balance is \$585. Member requests a waiver of his 2013 licensing fees and late payment penalty as well as a waiver of all future licensing fees. Member's request is based on medical hardship. Member has received 5 hardship waivers in the past 5 years. Member has submitted a statement and supporting documentation.

**Howard A. Emmer (#102675)** Admitted June 10, 1982. Current status is Inactive. Member has a balance of \$385. Request is made by member's wife on his behalf. Member requests a waiver of his current balance, which represents the difference between the Active and Inactive license fees, along with the \$100 late payment penalty. Request is based on financial and medical hardship. Member has not received a waiver in the past 5 years. Member has submitted a statement and supporting documentation.

**Nathaniel Glover (#90663)** Admitted November 30, 1979. Current status is Active. Member's current balance is \$100. Member requests a waiver of the 2013 late payment penalty. Member's request is based on medical hardship. Member has not received a hardship waiver in the past. Member has submitted a statement.

**Daniel J. Goodstein (#97579)** Admitted May 29, 1981. Current status is Active. Member's current adjusted balance is \$175. Member requests a waiver of his current balance. Member's request is based on financial and medical hardship. Member has received 5 hardship waivers in the past 5 years. Member has submitted a statement

**Mark Jay Hanson (#277323)** Admitted June 28, 2011. Current status is Active. Member's current balance is \$510. Member requests the Inactive rate for 2013. Member's request is based on financial hardship. Member has not received a waiver in the past 5 years. Member has submitted a statement and a financial declaration

**Karen Valerie Jampolsky (#179297)** Admitted December 4, 1995. Current status is Active. Member's current balance is \$510. Member requests a waiver of her 2013 licensing fees and late payment penalty. Member's request is based on financial hardship. Member has received 1 hardship waiver in the past 5 years. Member has submitted a statement and a financial declaration.

**Scott Kaplan (#188920)** Admitted June 3, 1997. Current status is Active. Member's current balance is \$510. Member requests a waiver of the 2013 licensing fees and late payment penalty. Member's request is based on financial hardship. Member has received 4 waivers in the past 5 years. Member has submitted a statement and a financial declaration.

**Melodie Kleiman (#51065)** Admitted January 5, 1974. Current status is Active. Member's current balance is \$202.50. Member requests late fee scaling and a waiver of the \$100 late payment penalty. Member's request is based on financial hardship and her claim that she attempted to pay online but was unable to complete her transaction. Member has not received a waiver in the past 5 years. Member has submitted a statement, a financial declaration and supporting documentation.

**Serge Kohan (#229605)** Admitted December 26, 2003. Current status is Inactive. Member's current balance is \$155. Request is made by member's spouse on his behalf. Member requests a waiver of his outstanding balance. Member's request is based on financial and medical hardship. Member has received a waiver in 4 of the past 5 years. Member has submitted a statement and a financial declaration.

**Glen Patterson (#87562)** Admitted October 22, 1979. Current status is Inactive. Member's current balance is \$155. Member requests a waiver of the 2013 licensing fees and late payment penalty. Member has received 1 hardship waiver in the past 5 years. Member has submitted a statement and financial declaration.
