Annual Recommendation re Members in Non-compliance with MCLE Audit

We have now completed 3 years of enhanced MCLE Audits. Starting with the 2014 Audit, we are prepared to tighten the Audit schedule so that it does not overlap with the printing of the next year's membership fee statements, which starts at the beginning of November. In past years the overlap has been challenging. In order to rectify this, we need to get the Board permission to place those who are not in compliance on Administrative Inactive status effective November 1st instead of later in November. Proposed Change to Name of "Associate" Section Members

Proposed Changes to Special Master Rules Regarding Eligibility Requirements

A concern was raised at a previous MOC meeting regarding the current Special Master eligibility requirement that an attorney must "not have been disciplined in any court or jurisdiction during the preceding five years". The debate was whether this requirement is strict enough. This agenda item proposes a change to Special Master rule 7.101(B)(2), that would require instead that an attorney applying to serve as a Special Master not have been disciplined in any court or jurisdiction during the preceding ten years. At the July meeting, staff will seek MOC's approval to release this rule change for public comment, and then will return to MOC and the BoT with a recommendation in November.

Proposed Amendment to Legal Specialization Fees

The California Board of Legal Specialization is recommending that the Legal Specialization schedule of fees be amended, which would establish a new discounted annual fee for subsequent areas of specialization for those legal specialists who are already certified in one area of specialization, effective January 1, 2015. Currently, specialists pay \$360 per specialty, but under this new proposal, they would pay \$180 as the annual fee for any specialty beyond the first specialty if they are dual or triple certified specialists.

The President Emeritus or Trustee Emeritus status will recognize, and extend the State Bar's access to, demonstrated and extraordinary skills and unique assets useful to the next President and the Chief Executive Officer, in partnership with State Bar staff, in implementing initiatives and activities to accomplish the State Bar's public protection mission. The President Emeritus or Trustee Emeritus will not be a member of the Board of Trustees nor sit at the dais, but may attend and participate in Board meetings as needed and coordinated by the CEO and the current President.
