WHEREAS, the Board needs to confer with its legal counsel regarding the litigation in Dunn v. State Bar on matters in that case before May 21, 2015, and the Board was unable to complete its consultation with counsel at its regular meeting on May 8, 2015;

RESOLVED, that the Board hereby finds a 10 day notice before the meeting would cause unnecessary delay and substantial hardship and that immediate action is required to protect the public interest in the matter.

Torre Dahlin addressed the board in open session about the discipline system and provided written materials as part of the public comment moment.
