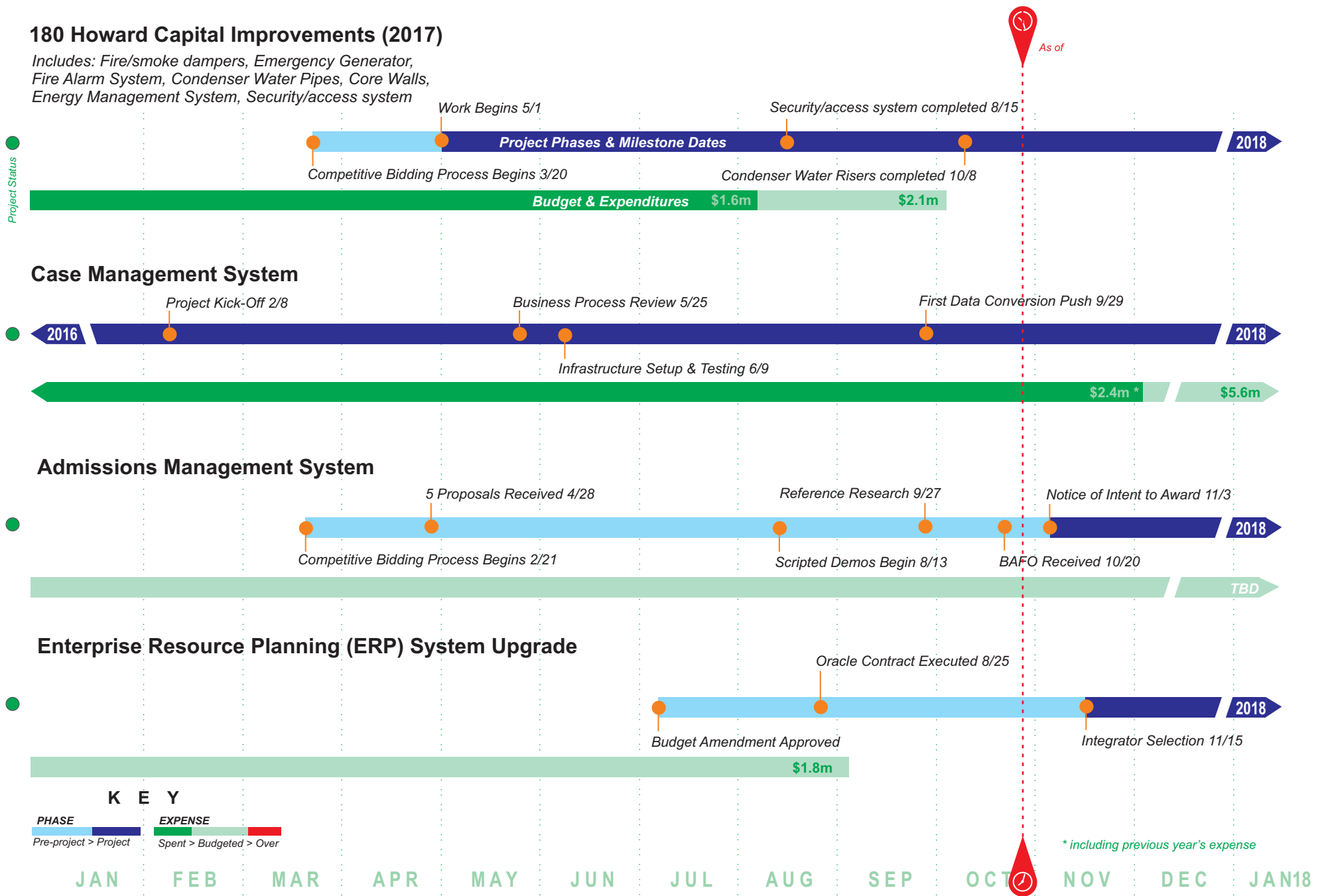

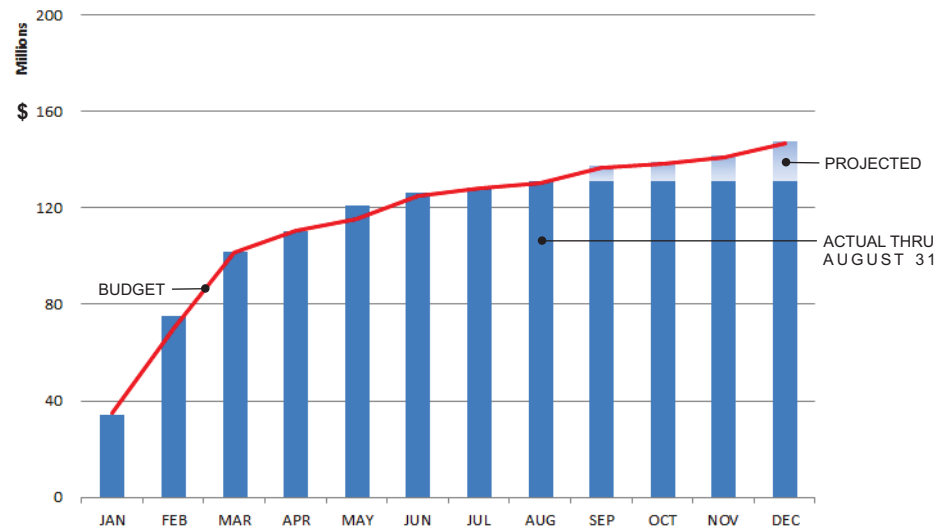

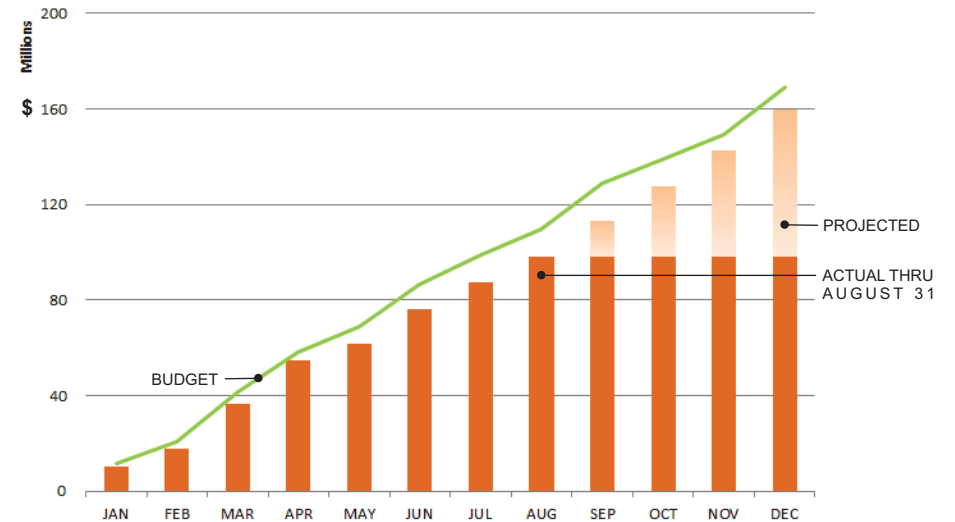


2017 Financial Dashboard

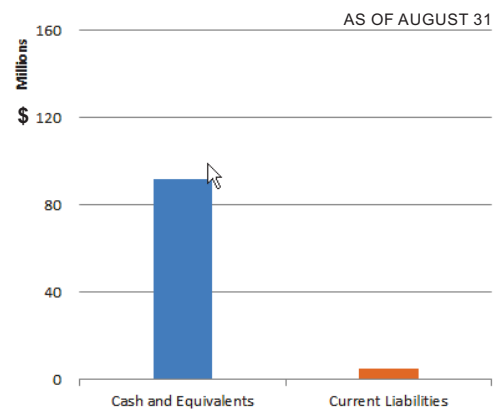
Cumulative Revenues



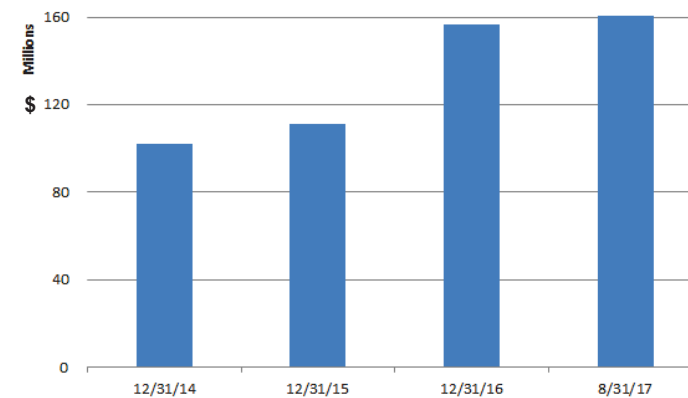
Cumulative Expenses



Liquidity

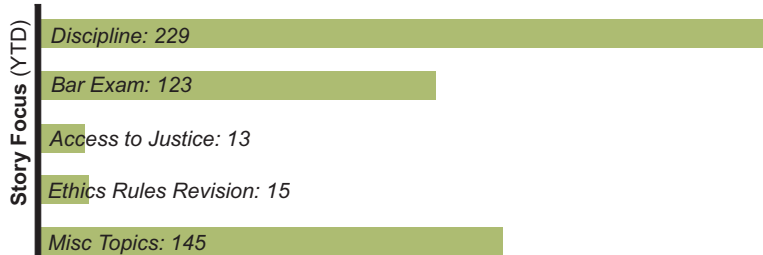


Net Position (ASSETS - LIABILITIES)

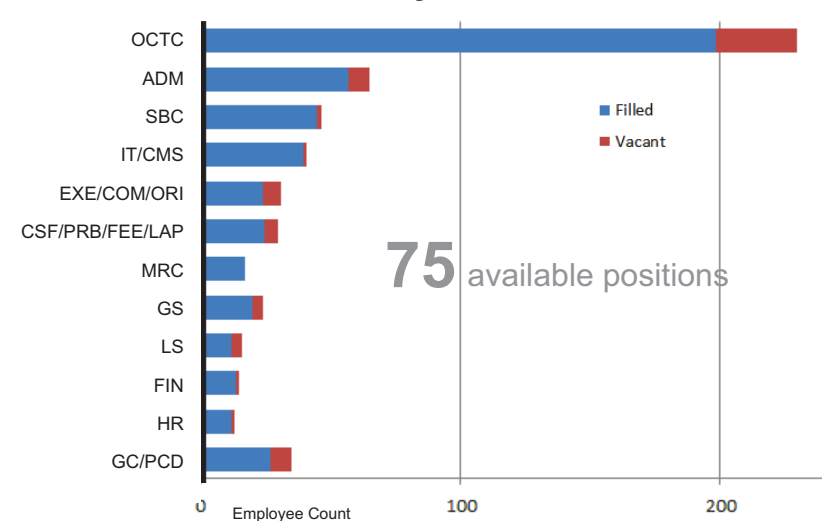

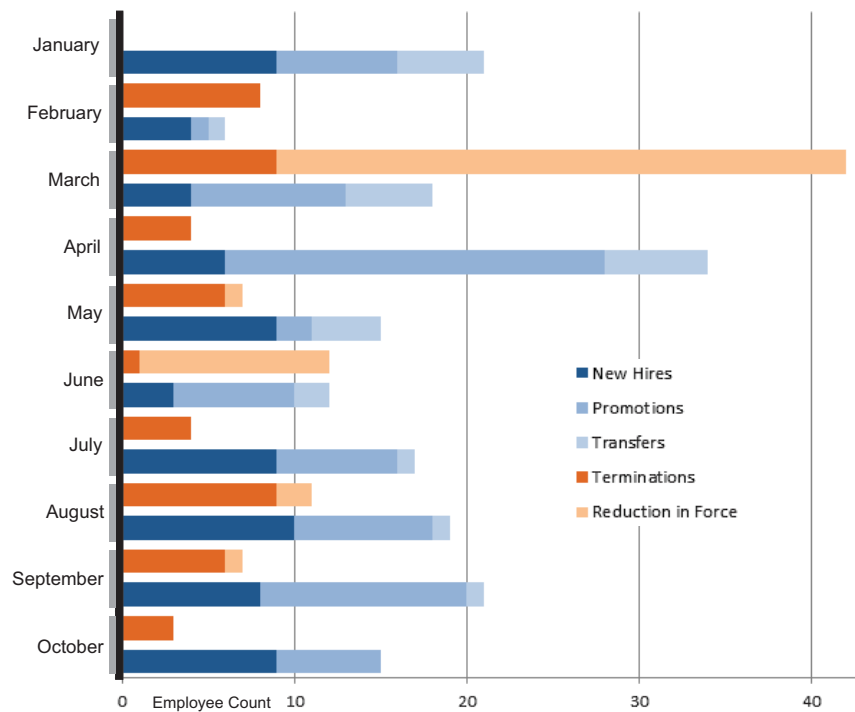
Employee Type
