REQUEST FOR WAIVER OF GUIDELINE 6.5(A)

It was moved, seconded and duly carried that the petition submitted by the law school on behalf of potential J.D. candidate seeking a waiver of the 84-month limitation for the completion of law study to earn a Juris Doctor degree under Guideline 6.5(A) of the *Guidelines for Accredited Law School Rules* be received and filed; that the petition be denied; and that the school be directed to advise the candidate of this decision within fifteen days of receipt so that she may choose whether and how to continue her law study.

THOMAS JEFFERSON SCHOOL OF LAW PETITION FOR CALIFORNIA
ACCREDITATION AND ACQUIESCENCE TO NON-J.D. PROGRAMS

It was moved, seconded and duly carried that the application for Thomas Jefferson School of Law (TJSOL) for Accreditation by the Committee of Bar Examiners (Committee), and its request for a waiver of all Rules found in the *Accredited Law School Rules* relating to the process and timing of Committee accreditation, be received and filed; that the Committee confirm that TJSOL is currently deemed accredited as a California Accredited Law School; that if TJSOL's ABA accreditation and approval is withdrawn, waivers of Rules 4.121 through 4.145 of the *Accredited Law School Rules* be granted; that the application for accreditation be granted, effective October 19, 2018; that the Committee acquiesce to the school's non-J.D. LL.M., M.S.L. and J.S.D. programs; and, that the school's name be included on the list of law schools accredited by the Committee effective immediately. This would be conditioned upon the school's agreement to undergo a full inspection within twelve months of any lapse of ABA accreditation and to pay all inspection fees assessed by the State Bar of California under the Schedule of Charges and Deadlines.

It was by common consent agreed that the notice from California Southern School of Law of the appointment of Virginia Suveiu as Interim Dean, effective September 2018 be received and filed.
