SUBJECT: Annual Recommendation for Appointment and Reappointment of Fee Arbitrators and Reappointment of Presiding Arbitrator and Assistant Presiding Arbitrators

EXECUTIVE SUMMARY

The State Bar's Mandatory Fee Arbitration Program (Program) maintains a roster of volunteer fee arbitrators throughout the state to hear fee dispute matters administered by the State Bar. There are approximately 451 lawyer and nonlawyer arbitrators on the State Bar's panel. The Board of Trustees appoints the arbitrators to one-year terms of service, which are renewable by the Board.

This agenda item requests approval of the reappointment of the current roster of arbitrators listed in Attachment A, the appointment of one new attorney arbitrator, and the reappointment of the Program's current Presiding Arbitrator and two Assistant Presiding Arbitrators.

BACKGROUND

The State Bar's Fee Arbitration Program maintains a roster of volunteer attorney and lay arbitrators to hear attorney-client fee disputes. Although most fee arbitration cases are conducted by approved local bar associations, the State Bar Mandatory Fee Arbitration

Program accepts fee arbitration requests in three instances: (1) when there is no local bar program; (2) when the local program lacks jurisdiction to hear the fee dispute; or (3) when a party asserts and it is determined that the party cannot obtain a fair hearing through the local bar association. The State Bar's fee arbitrators hold hearings in the county where substantial legal services were rendered. Therefore, the State Bar Mandatory Fee Arbitration Program must maintain a roster of qualified volunteer fee arbitrators for possible assignment of fee arbitration matters in every county throughout the state.

DISCUSSION

1. Re-appointment of Current Fee Arbitrators

Currently, the Mandatory Fee Arbitration Program consists of approximately 451 attorney and lay arbitrators from counties throughout the state. The Board of Trustees appoints these volunteer fee arbitrators to serve for one-year terms subject to annual reappointment. The list of current volunteer arbitrators, set forth in Attachment A, has been screened to remove the names of lawyer arbitrators who changed their licensee status to inactive, died, currently have pending discipline, or received public discipline since last year's appointment. The arbitrators on this list, sorted alphabetically by last name, are recommended for reappointment to the State Bar Fee Arbitration Program, each for a one-year term commencing January 1, 2020 and expiring December 31, 2020.

2. Appointment of New Fee Arbitrators

The application of one (1) attorney candidate, Paul Dubow, was reviewed to ensure that he meets the Guidelines and Minimum Qualifications of Arbitrators for appointment to the State Bar Mandatory Fee Arbitration Program.¹ Attorney arbitrators must be admitted to the practice of law in California and currently be in good standing for a period of at least five years and have no public record of discipline; lay arbitrators must not be admitted to practice law in any jurisdiction or have worked regularly for a public or private law office, court of law, or attended law school for any period of time.

In addition, attorneys' names are submitted to the Office of Chief Trial Counsel (OCTC) to ascertain whether they have any disqualifying public reportable actions or criminal convictions. For these purposes, public reportable actions include:

- Imposition of judicial sanctions, including contempt orders and nondiscovery sanctions in excess of \$1000;
- Felony indictment, felony or misdemeanor charge, pleas or conviction;
- Reversal of judgment in a proceeding for professional misconduct;
- Filing of three or more civil suits for malpractice in 12 months;
- Discipline in another jurisdiction;

- Claims or actions for damages in a civil suit for professional misconduct, regardless of the outcomes (reported by professional liability insurance companies); and
- Judgments, settlements, or awards in a civil suit for professional misconduct.

OCTC's review of Mr. Dubow did not find any public discipline, convictions, or public reportable actions, and he otherwise meets the eligibility criteria. Staff therefore recommends that Mr. Dubow be appointed as a fee arbitrator for the State Bar Mandatory Fee Arbitration Program for a term commencing November 14, 2019 and expiring December 31, 2020.

Arbitrators who have not already attended a fee arbitrator training program will be required to attend a training program before a case is assigned to them, unless they have prior fee arbitration experience through a local bar program.

3. Re-appointment of Presiding Arbitrator Kenneth E. Bacon

The State Bar's Presiding Arbitrator is responsible for supervising the State Bar Mandatory Fee Arbitration Program's arbitrators, providing guidance to staff on legal issues affecting cases, issuing decisions on issues that arise in the program, and representing the State Bar before the State Bar Court in assisting clients with the enforcement of unpaid fee arbitration awards and judgments owed by an attorney.

Kenneth E. Bacon, Sacramento, has been an arbitrator for the State Bar of California since 1999 and is just completing his seventh term as Presiding Arbitrator. In September 2019, Mr. Bacon began a four-year term as a member of the State Bar Committee on Professional Responsibility (COPRAC), which will assume some of the duties that were performed by the Committee on Mandatory Fee Arbitration (CMFA). Mr. Bacon was a member of the CMFA from 2007 through 2019 and served in several leadership positions, including Vice Chair and Chair during the 2010-2011 and 2011-2012 committee years, respectively. Since 2011, Mr. Bacon has also served as Chair for the Sacramento County Bar Association Mandatory Fee Arbitration Program.

Mr. Bacon is certified as a Specialist in Legal Malpractice Law by the State Bar of California Board of Legal Specialization. He has represented and advised attorneys and law firms in legal malpractice cases, ethics and risk management matters, fee disputes, fee arbitrations, State Bar disciplinary actions, and malicious prosecution cases since 1988. He has presented many MCLE programs on behalf of the State Bar on the issue of fee arbitration and ethical considerations for attorneys in the arena of legal fees, including the 2019 Ethics Symposium held in Los Angeles earlier this year.

Mr. Bacon's significant contributions to and institutional knowledge of the Mandatory Fee Arbitration Program are of great value to the State Bar's Program. Mr. Bacon is a highly

respected member of the MFA community. Therefore, it is recommended that Mr. Bacon be reappointed as Presiding Arbitrator for a one-year term commencing January 1, 2020 and expiring December 31, 2020.

3. Re-Appointment of Assistant Presiding Arbitrators Clark Stone and Lee Straus

The State Bar's two Assistant Presiding Arbitrators (APAs) hear fee arbitrations involving less than \$1,000 in dispute and issue decisions on fee waiver requests for the fee arbitration program. In addition, the Presiding Arbitrator may request that an APA step in as his designee when the Presiding Arbitrator is unavailable or unable to decide a matter due to a conflict. Generally, one APA is from Northern California and one APA is from Southern California to ensure availability throughout the state.

Clark Stone, San Jose, has served as APA since 2017. Mr. Stone has been a fee arbitrator for the State Bar program since 2005 and with the Santa Clara County Bar Association program since 2001. Mr. Stone has participated in countless fee arbitrator trainings throughout the state. He is presently a sole practitioner in San Jose with an emphasis on general litigation in the technology industry relating to patents, trademarks, and trade secret misappropriation.

Lee Straus, Los Angeles, like Mr. Stone, has also served as APA since 2017. Mr. Straus is Executive Vice President for Business Affairs at NBC Entertainment, Universal Television Alternative Studio and Universal Television Syndicated Distribution in Los Angeles. He has served as an arbitrator for the Los Angeles County Bar Association fee arbitration program for the past 20 years and also teaches at Loyola Law School as an Adjunct Professor of Law, where he has taught more than 600 students over the last 20 years. Mr. Straus consistently participates in fee arbitration trainings and was instrumental in creating a new advanced fee arbitrator training program in 2018.

Both Mr. Stone and Mr. Straus enrich the State Bar Program with their extensive fee arbitration experience. Thus, it is recommended that Mr. Stone and Mr. Straus be reappointed as Assistant Presiding Arbitrators for a one-year term commencing January 1, 2020 and expiring December 31, 2020.

**Guidelines & Minimum Qualifications of Arbitrators
for the State Bar Fee Arbitration Program**

(Adopted by the State Bar Committee on Mandatory Fee Arbitration
2001; revised May 12, 2006; revised January 12, 2007; revised May
3, 2019.)

I. Arbitrator Appointments Selection Committee

The Appointments Selection Committee shall consist of the Presiding Arbitrator and at least one staff member from the State Bar of California's Mandatory Fee Arbitration Program. Recommendations for appointments of arbitrators are submitted to the appropriate State Bar Board Committee, which in turn forwards its recommendations to the full Board of Trustees of the State Bar for appointment.

II. Guidelines for Minimum Qualifications of Arbitrators

- A. The following guidelines are intended to set forth the minimum qualifications for lawyer and non-lawyer arbitrator appointments as well as the retention of appointees on the arbitrator panel. Any information provided by the applicant on his or her application form will be evaluated and could be used as grounds for exclusion from appointment. An applicant's failure to show, upon request of the Appointments Selection Committee, that he/she affirmatively meets these minimum qualifications may result in the rejection of an applicant or removal of an arbitrator from the Fee Arbitration Program.
- B. In addition, the Appointments Selection Committee may consider, within its sole discretion, any additional factors it may deem relevant in connection with any decision to accept or exclude any applicant.

III. Appointment to the Mandatory Fee Arbitration Panel

A. Requirements of All State Bar Fee Arbitrators

Prior to assignment to a panel, arbitrators are required to attend at least one comprehensive training program for arbitrators on attorney fee arbitration through a local bar association or the State Bar of California.

B. Lawyer Arbitrators

To be qualified for appointment as a lawyer arbitrator, an applicant must:

- (1) be, and have been for at least five years, an active member in good standing with the State Bar of California; or
- (2) be a retired judge who is an active member of the State Bar of California;

and

- (3) not have a pending professional disciplinary matter filed with the State Bar Court, any federal court or agency, or other state bar discipline authority. Conviction of a crime for any felony or misdemeanor required to be reported under Business & Professions Code section 6068(o)(5) may constitute grounds for rejection of the applicant. The imposition of any public discipline by the State Bar Court, or a federal court or agency or other state bar discipline authority authorized to impose comparable professional discipline against attorneys may also constitute grounds for rejection of an application.

1. Non-Lawyer Arbitrators

To be qualified for appointment as a non-lawyer arbitrator an applicant must:

- (1) provide sufficient information to the Appointments Selection Committee to its satisfaction concerning his or her business, professional or volunteer experience, education, or other relevant qualifications to serve as an arbitrator; and
- (2) have never been an active or inactive member of the bar of any state or the District of Columbia; and
- (3) have never worked regularly for a public or private law office or practice, court of law or attended law school for any period of time; and
- (4) have never worked as a paralegal, law firm staff, or law clerk.
- (5) have never been convicted of a felony, or a misdemeanor involving dishonesty or other moral turpitude, or an attempt or a conspiracy or solicitation of another to commit a felony or a misdemeanor of any type.

IV. Ongoing Requirements

- A. During the term of service, all lawyer arbitrators are required to report to the Fee Arbitration Program the existence of any professional disciplinary complaint filed with the State Bar Court or imposition of public professional discipline by the State Bar of California or by any federal court or agency authorized to impose comparable professional discipline against attorneys.
- B. During the term of service, all lawyer arbitrators are required to report to the Fee Arbitration Program the existence of any criminal conviction of a felony or misdemeanor required to be reported under Business & Professions Code section 6068(o)(5).
- C. During the term of service, all non-attorney arbitrators are required to report to the

Fee Arbitration Program the existence of any criminal conviction of a felony, or a misdemeanor involving dishonesty or other moral turpitude, or an attempt or a conspiracy or solicitation of another to commit a felony or a misdemeanor of any type.

- D. Once appointed, all arbitrators shall attend a comprehensive training at least once every five (5) years.
