SUBJECT: Approval of Report on 2021–2022 Educational Standards Goals

EXECUTIVE SUMMARY

Below is the report on the goals for Educational Standards for 2021–2022.

BACKGROUND

The report on the goals for Educational Standards for 2021 to 2022 is listed below for the approval of the Committee of Bar Examiners (CBE).

1. Maintain and enhance law school engagement by conducting meetings with the Committee of State Bar Accredited and Registered Schools (CSBARS) and the Law School Council (LSC), publishing the quarterly Law School Deans' eNewsletter, and hosting annual Law School Assembly and Registrars' Meetings. Note the new date for the Law School Assembly, in order to avoid a conflict with a meeting of the Board of Trustees.

 - Annual Registrars' Meeting: September 20, 2022
 - Quarterly Dean's eNewsletters
 - Law School Council: December 1, 2022; April 20, 2022
 - Committee on State Bar Accredited and Registered Schools

2. Review petitions for registration and accreditation, as well as existing registered and accredited schools' petitions for changes.

3. Regulate law schools by monitoring compliance through inspections, reporting, and other actions as directed by the Committee, addressing noncompliance as needed.

4. Implement new rules for accredited law schools, effective January 1, 2022.

5. Review petitions for individual waivers related to the pandemic after the State Bar's general waiver ends on December 31, 2021.

6. Review progress reports and waivers submitted with Annual Compliance Reports.

INITIAL REVIEWS COMPLETED IN MARCH 2022.

7. Begin the process of reviewing the Rules for Unaccredited Law Schools to determine whether updates are needed.

APRIL 2022; INITIAL REVIEW OF GUIDELINE 1.11 REFERRED TO CSBARS.

8. Schedule a presentation with a national or regional institutional accreditor.

AUGUST 2022

9. Review Minimum, Cumulative Five-Year Bar Pass Rate statistics from accredited law schools for compliance.

AUGUST 2022

10. Continue to support the State Bar's strategic initiatives related to law school diversity, retention, and performance on the Bar examination.

Gender categories and attrition tracking were added to the 2021 periodic compliance report templates returned in November 2021. The 2022 periodic reports will add sexual orientation and veteran status of students and faculty.

11. Continue to pursue mandatory accreditation for unaccredited law schools in accordance with the Rules and Guidelines approved by the Committee of Bar Examiners and the Board of Trustees.

12. Study process related to teach outs and closures to determine best practices to preserve student records and minimize disruption to legal education.
